## MAGIC 93'S "Frankie's Birthday Bash Cruise" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WMGS ("Station"), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies, 600 Baltimore Drive, Wilkes-Barre, PA 18702, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **Magic 93's "Frankie's Birthday Bash Cruise"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF 1. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY. **Eligibility.** This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age twenty-one (21) or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the 30 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the **last 30 days. The term "immediate family members" includes spouses, parents and stepparents, siblings and stepsiblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - 2. **Contest Period.** The Contest will begin at **6:00 a.m., ET on January 13, 2020** and will run through **7:00 p.m., ET on February 7, 2020** (the "Contest Period"). This Contest will not be played on Martin Luther King Jr. Day (January 20, 2020). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:
  - (i) On-Air: Listen to the Station weekdays from 6:00 a.m. to 11:59 a.m., and 2:00 p.m. to 6:00 p.m. during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 1-800-624-4293. Caller ten (10) to the Station, as determined by the Station in its sole discretion, will be entered to win. Time Delay Between Over-the-Air Analog Signal and **Internet Broadcast:** Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of online listener entering this Contest on-air may diminished. an be
  - (ii) Online: Visit the Station's website <a href="www.magic93fm.com">www.magic93fm.com</a> during the final week of the Contest Period, beginning at 6:00 a.m., ET on February 3, 2020 and through 5:59 p.m., ET on February 7, 2020. Click on the "Contest" link, click on the "Frankie's Birthday Bash Cruise" Contest link, and complete an entry form. All entries must be received by 5:59 pm ET on February 7, to be eligible for the Grand Prize drawing. Station will select three (3) entries to be eligible for Grand Prize drawing at random from among all valid entries received by Station during the Contest Period. That name will be announced on-air and notified via telephone. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

one (1) entry per person per day per email address. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

- Winner Selection. On February 8, 2020 from 11:30 a.m. until 1:00 p.m. at Travelworld at 601 Market 4. Street, Kingston, PA, 18702. Qualifiers must check-in no and remain present for the duration of the Contest to win. Qualifiers must present a current, government issued photo identification and check-in with the Station no later than 11:59 a.m., in order to continue in the Contest. Any person failing to check in on time and/or who fails to present a government issued photo identification will be disqualified and will not be allowed to continue in the Contest. The contest begins with a box filled with all sixty (60) qualifiers names and all sixty (60) qualifiers standing. As time goes on, Magic 93's on-air personality, Frankie Warren, will draw names from the box. Whoever's name is called will sit down and immediately be eliminated from Grand Prize drawing. The final qualifier standing is declared the winner for the Grand Prize winner of a cruise for two (2). If it is determined that the candidate is not eligible to receive the grand prize, in the Station's sole judgment and discretion, another candidate will be randomly selected for eligibility consultation. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. The Grand Prize is a trip for two (the winner and a guest) to cruise aboard Travelworld's "Royal Caribbean's Oasis of the Seas" July 11-18, 2020 to the Bahamas, which consists of round-trip motor coach from Wilkes-Barre/Scranton to the pier at Cape Liberty, New Jersey, and seven (7) nights Inside Cabin, double-occupancy cabin accommodations on the Royal Caribbean as selected by Station. **ARV** five thousand dollars (\$5000). - 7. Entry Conditions and Release. Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry

process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

- 11. **Limitations of Liability.** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
- 12. **Disputes.** Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR

ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.

- 13. **Entrant's Personal Information.** Information collected from entrants is subject to Station's Privacy Policy, which is available on the Station's website under the "Privacy Policy" link. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
