MAGIC 93'S "TEXT TO WIN WEEKEND" CONTEST OFFICIAL RULES

The Station will conduct the **Magic 93's "Text To Win Weekend"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. Contest Period. The Contest entry period will begin at 12:00pm ET on Friday, May 23, 2025 and will run through 11:59pm ET on Sunday, May 25, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** There is one (1) way to enter:

<u>Text</u>: Send a text message with the keyword RACE spelled correctly to 570-208-1383 during the Contest Period. All entries must be received by 11:59pm ET on Sunday, May 25, 2025 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

- 4. **Winner Selection.** On or about 11:00am ET on Tuesday, May 27, 2025 Station will select ONE (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
